BE LIKE CASEY SCHOLARSHIP (GRANT) SUMMARY DESCRIPTION: The Casey Saunders Foundation is providing two \$1,500.00 Scholarships (Grants) to participate in cycling for two selected youths, 8-18 years old, who reside in the St. Louis Area. The Scholarships (Grants) will be given to individuals who demonstrate a commitment to the characteristics of humility, hard work and helpfulness. Cycling Scholarships (Grants) can be used in support of the cycling experience chosen by the youth, and used for items including but not limited to cycling camps, gear, event participation fees, transportation and entry fees. Applications/Nominations must be received by May 10, 2019. Application details provided on Application.

Applicants (Nominees) must be between 8-18 years of age. Applicants may nominate themselves. Applicants 17 and under must provide approval by parent or legal guardian as per required by the application.

START AND END DATES/TIMES:

Dates and times for nomination period noted below. *Note - all times are CDT

Nominations are open between April 12 and May 10, 2019 at 5:00 PM.

Online Entries must be submitted by May 10, 2019 at 5:00 PM.

Mail-in Entries must be postmarked by May 10, 2019.

Entries received or postmarked after this date/time will not be considered in this round of Scholarships (Grants).

ELIGIBILITY:

- Applicant (Nominee) must reside in the St. Louis (bi-state) metropolitan area (as defined by the [St. Louis Regional Chamber](#)) and be between the ages of 8 and 18 years of age at time of submission.

- Individuals employed by Casey Saunders Foundation or the selection committee members or members of their immediate families, are not eligible.
- Applicants (Nominees) agree to comply with these Official Rules. Casey Saunders Foundation (Sponsor) reserves the right and has the sole discretion to disqualify any entry at any time which, in Sponsor's opinion, does not comply with these Official Rules.

SUMMARY TERMS OF NOMINATION:

- A Nominator may enter themselves or someone else as a nominee.
- If Applicant (Nominee) is under 18, he or she must have parent or guardian sign entry.
- A Nominator may submit multiple nominees as long as each entry is a separate entry, meets all requirements, and if submitted by mail, is sent in a separate outside envelope.

Submission of Applications and Determining the Finalists

HOW TO APPLY: There are two (2) ways to apply: Online or by regular mail.

1. **TO APPLY ONLINE:** Visit www.belikecasey.org/application and complete the application form as directed. Include any supplemental documents, as described on form. Submit Application (Nomination) Form by email to belikecasey@gmail.com with "Scholarship Application [NAME OF NOMINEE]" as Subject line by May 3, 2019 at 5:00 p.m. CDT. Include any supplemental documents, as described on form. Must be received by date and time above.
2. **TO APPLY BY MAIL:** Visit www.belikecasey.org and download, print and complete Application form. Mail to Be Like Casey Scholarship Program, C/O Casey Saunders Foundation, 7253 Watson Road, PMB 12, St. Louis, MO 63119-4401 by May 3, 2019. Include any supplemental documents, as described on form. Must be postmarked by date above.

PLEASE NOTE: Illegible, incomplete or inaccurate, late, lost, postage-due, misdirected or undeliverable entries will not be accepted.

IMPORTANT INFORMATION ABOUT YOUR ENTRY:

- Applicant/Nominator certifies that the submission is original work, accurate to the Applicant's/Nominees service, and that he/she has all rights to the submission; published, released, or distributed; and is suitable for the Scholarship (Grant) program.
- Applicant/Nominator/Nominee allows Sponsor the rights to use any photos, video or other materials pertinent to the entry for Sponsor's promotional purposes including publicity, marketing and social media.

- Applicant/Nominee understands that Sponsor will not return entries.
- Only selected Entries will be contacted.
- The final selections will be announced by the Casey Saunders Foundation, BeLikeCasey.org website no later than June 15, 2019.

JUDGING CRITERIA: Award will be based on an essay from the applicant in response to criteria in application and letters of reference. See application for details on items to submit for judging.

All eligible entries received will be scored by our Casey Saunders Foundation Scholarship Advisory Board.

VALUE: \$1,500.00 each with total value for the two scholarships of \$3,000.00

Scholarships (Grants) will be awarded to selected Applicants/Nominees or parent/legal guardian on behalf of selected Nominee if a minor. U.S. charitable donation prize will be issued from the Casey Saunders Foundation. All prize values are based on the U.S. Dollar and exchange rates will be based on these above stated values.

TERMS:

Scholarship (Grant) Recipients allow a representative of the Casey Saunders Foundation to contact them - via email, phone and/or mail - during and after the nomination process as well as before, during and after their cycling experience. The information collected will be used to ensure the Scholarship (Grant) is being used for its intended purpose or as promised by the Recipients and/or the Recipient's representative (family member, guardian, etc.).

SCHOLARSHIP NOTIFICATION & CONDITIONS: Scholarship (Grant) Recipients will be notified no later than June 15, 2019. Non-Recipients will not be notified. Recipients may be contacted by telephone and be required to complete a phone interview with a representative of the Casey Saunders Foundation. Potential Finalists and their parent/legal guardian will be required to complete and return within seven (7) days an Affidavit of Eligibility and release of liability/publicity in order to qualify. Sponsor retains the right to select alternate recipients based on nominations received.

Scholarships (Grants) are not transferable and cannot be assigned, redeemed for cash, substituted (except by Sponsor, in its sole discretion) and will not be replaced if lost, stolen, or misplaced by Recipient. If a Recipient is 17 or under, Scholarship will be awarded to parent/legal guardian on behalf of selected Nominee as indicated on the Nomination form. All taxes on prizes won by a U.S. resident and other expenses

related to accepting the prize are the sole responsibility of the selected nominee and parent or legal guardian of the Winner.

GENERAL RULES: All Scholarships (Grants) will be awarded, provided more than enough qualified Applications/Nominations have been received. Decisions of the Sponsor and judging Committee are final and binding in all respects of the Casey Saunders Foundation Scholarship Program.

WAIVER, RELEASE AND LIMITATION OF LIABILITY: By submitting, Applicants/Nominators and Nominees hereby acknowledge that their nominations are voluntary and waive, release and agree to hold harmless the Sponsor, its subsidiaries, partners, agencies and employees of these companies (collectively, "The Releasees") from and against any and all rights, demands, claims, causes of action whatsoever which Nominator and/or Nominee may now have, or which may inure to their benefit in the future, against any of the Releasees for any liability for any matter, cause or thing whatsoever--including but not limited to any damage, injury, loss whether direct, compensatory, incidental or consequential, including death, to person and property--arising in whole or in part, directly or indirectly, from their acceptance of the Scholarship their nomination or their participation in any scholarship related activity, or any travel related to the Scholarship related activity. By accepting a Scholarship, the Nominee, or Nominee's parent/legal guardian if Nominee is a minor, grants permission for their description, likeness, statements, and biographical information (including name, city and state) to be used without limitation or further compensation, for advertising and publicity purposes, except where prohibited by law.
